### BYLAW NO. 34

#### DISTRICT OF LANGFORD TICKET INFORMATION AUTHORIZATION BYLAW, 1993

##### WHEREAS

- A. Pursuant to Section 934.1(1)(a) of the municipal Act, the Council may, by bylaw, designate those bylaws for which the municipal ticket information may be used as a means of Bylaw Enforcement.
- B. Pursuant to Section 934.1(1)(b) of the Municipal Act, the Council may, by bylaw, designate a person who comes within a class of persons, as a Bylaw Enforcement Officer.
- C. Pursuant to Section 934.1(1)(c) of the Municipal Act, the Council may, by bylaw, authorize the use of any word or expression on a municipal ticket information to designate an offence against a Bylaw.
- D. Pursuant to Section 934.1(10) of the Municipal Act, the Council may, after consultation with the Chief Judge of the Provincial Court, by bylaw, set a fine, not exceeding \$500.00 for contravention of a Bylaw; and
- E. The Council deems it expedient to authorize the use of the Municipal Ticket Information for the enforcement of certain bylaws, to designate persons as Bylaw Enforcement Officers, to authorize the use of certain words or expressions to designate certain bylaw offenses and to set certain fine amounts.

NOW THEREFORE, the Council of the District of Langford, in open meeting assembled hereby enacts as follows:

- 1. The bylaws listed in Column 1 of Schedule 1 to this Bylaw as amended from time to time, may be enforced by means of a ticket in the form prescribed for the purpose of Section 934.1 of the Municipal Act.
- 2. The persons appointed to the job positions or title listed in Column 2 of Schedule 1 to this bylaw are designated as Bylaw Enforcement Officers pursuant to Section 934.1(1)(b) of the Municipal Act for the purpose of enforcing the bylaws listed in Column 1 opposite the respective job positions.
- 3. The words or expressions set forth in Column 1 of Schedules 2 through 10 to this bylaw designate the offence committed under the bylaw section number appearing in Column 2 opposite the respective words or expressions.

4. The amounts appearing in Column 3 of Schedules 2 through 10 to this bylaw are the fines set pursuant to Section 934.1(10) of the Municipal Act for the corresponding offenses designated in Column 1.
5. This bylaw may be cited as "District of Langford Ticket Information Authorization Bylaw, 1993".
6. This Bylaw shall take effect upon the date of its adoption.
