2026 GENERAL LOCAL ELECTION
NOTICE OF NOMINATION**

PUBLIC NOTICE is hereby given to the electors of the City of Langford that the nominations for the offices of one (1) Mayor and six (6) Councillors will be received by the Chief or Deputy Chief Election Officer or designated person from 9:00 a.m. Tuesday, September 1, 2026 to 4:00 p.m. Friday, September 11, 2026.

The term of office for a Mayor and six Councillors will be four years commencing in November 2026 and terminating after the 2030 General Local Election in accordance with the *Local Government Act*.

Nomination packages are available at Langford City Hall, second floor, 877 Goldstream Avenue, Langford, BC, starting 9:00 a.m. Monday, July 27, 2026, excluding statutory holidays and weekends.

Nomination documents will be received by hand, for filing with the Chief Election Officer at Langford City Hall, from 9:00 a.m. to 4:00 p.m. from Tuesday, September 1, 2026 through 4:00 p.m. on Friday, September 11, 2026, excluding statutory holidays and weekends.

Nomination documents must be received by the Chief Election Officer by 4:00 p.m. Friday, September 11, 2026.

QUALIFICATIONS FOR OFFICE

A person is qualified to be nominated, elected, and to hold office as a member of local government if they meet the following criteria:

- Canadian citizen;
- aged 18 years or older on general voting day (October 17, 2026);
- resident of British Columbia for at least six months immediately before the day nomination papers are filed;
- not disqualified under the *Local Government Act* or any other enactment from being nominated for, being elected to, or holding the office, or be otherwise disqualified by law.

CAMPAIGN PERIOD EXPENSE LIMITS

In accordance with the *Local Elections Campaign Financing Act*, for the 2026 General Local Election, and all subsequent elections, all candidates have expense limits that apply during the campaign period, September 19, 2026 to October 17, 2026. The following expense limits for candidates during the campaign period apply:

- Office of Mayor \$48,759.28
- Office of Councillor \$24,654.86

THIRD PARTY ADVERTISING LIMITS

In accordance with the *Local Elections Campaign Financing Act*, for the 2026 general local elections, the following third party advertising limits apply:

- Office of Mayor \$2,437.96
- Office of Councillor \$2,437.96
